## **USER LICENSE AGREEMENT**

(Enacted 2022)

This is the End User License Agreement ("Agreement") between you and the Rector and Visitors of the University of Virginia for use of the STREAMin<sup>3</sup> Curriculum Model.

This Agreement represents, and you agree it represents, the complete licensing agreement between the parties regarding the STREAMin<sup>3</sup> Curriculum Model and governs your access to and use of the curriculum.

This copy of UVA's STREAMin³ Curriculum Model and accompanying documentation is licensed and not sold. The STREAMin³ Curriculum Model is protected by copyright laws and treaties, as well as laws and treaties related to other forms of intellectual property. UVA or its subsidiaries, affiliates, and suppliers (collectively "UVA") own intellectual property rights in the STREAMin³ Curriculum Model. The Licensee's ("you" or "your") license to download, use, copy, print, or share the STREAMin³ Curriculum Model is subject to these rights and to all the terms and conditions off this Agreement.

# **Acceptance and Agreement to Terms**

You must agree to all of the terms of this Agreement for access to the STREAMin<sup>3</sup> Curriculum Model and training materials. Select "Agree and Continue" to view, use, download, print, and copy the STREAMin<sup>3</sup> Curriculum Model and training materials.

If you do not agree to all of the terms of this Agreement, do not select "Agree and Continue," which will prevent you from viewing, printing, using, or copying the STREAMin<sup>3</sup> Curriculum Model.

### **License Grant**

This Agreement entitles you to download, print, and use the STREAMin<sup>3</sup> Curriculum Model consistent with the terms herein. You may also share the STREAMin<sup>3</sup> Curriculum Model with other registered users. If you choose to share with other registered users, it is your obligation to confirm such user is in fact a registered user.

## **Restrictions on Transfer**

Without first obtaining the express written consent of UVA, you may not assign your rights and obligations under this Agreement, or encumber, sell, rent, lease, sublicense, or otherwise transfer your rights to the STREAMin<sup>3</sup> Curriculum Model in whole or in part.

You may freely exchange STREAMin<sup>3</sup> Curriculum Model with other registered users and it is incumbent upon you to ensure whoever you exchange the STREAMin<sup>3</sup> Curriculum Model with is a registered user.

### **Restrictions on Use**

The STREAMin<sup>3</sup> Curriculum Model is being provided by UVA for use by eligible

programs, schools, teachers, and Virginia Department of Education trainers within Virginia. You may elect to download and use any or all of the versions of the curriculum and training materials provided on the <a href="STREAMin3">STREAMin3</a> website.

You may not decompile, "reverse-engineer," disassemble, or create derivative works of the STREAMin<sup>3</sup> Curriculum Model or training materials.

## Copyright

No ownership or copyright in the STREAMin<sup>3</sup> Curriculum Model shall pass to you by the issuance of the license contained in this Agreement. Except as expressly stated in this Agreement, UVA grants you no right or license, express or implied, to the licensed material.

### **Prohibition on Modifications**

You are permitted to adapt the curriculum activities to individualize instruction for personal use to meet the needs of children in your classroom or program. You are permitted to adapt the training materials to individualize instruction for the educators you support. STREAMin3 is not responsible for any loss of quality caused by these modifications. You are permitted to develop supplemental resources for use alongside the STREAMin³ Curriculum Model but are not permitted to create any derivatives that compromise the integrity of the original content.

### **Unauthorized Use and Termination**

Any use of the STREAMin<sup>3</sup> Curriculum Model in a manner not expressly authorized by this Agreement constitutes copyright infringement, entitling UVA to exercise all rights and remedies available to it under copyright laws around the world. You shall be responsible for any damages resulting from any such copyright infringement, including any claims by a third party.

UVA reserves the right to terminate this Agreement in the event you: (i) enter the Agreement after having received notice of unauthorized use from UVA relating to the STREAMin³ Curriculum Model (ii) provide inaccurate information regarding the proposed use of the STREAMin³ Curriculum Model at the time of entering the Agreement; or (iii) otherwise breach the terms of this Agreement. Upon termination, you must immediately (i) stop using the STREAMin³ Curriculum Model; and (ii) destroy or, upon the request of UVA, return to UVA all copies of the STREAMin³ Curriculum Model.

# **Audit/Certificate of Compliance**

Upon reasonable notice, UVA may, at its discretion, either through its own employees or through a third party, audit your records directly related to this Agreement and use of the STREAMin<sup>3</sup> Curriculum Model in order to verify compliance with the terms of this Agreement. Where UVA reasonably believes that the STREAMin<sup>3</sup> Curriculum Model is being used outside of the scope of the license granted under this Agreement, you shall, at UVA's request, provide a certificate of compliance signed by you or an officer of your organization, in a form to be approved by UVA.

# **Electronic Storage**

You must retain the copyright symbol, the name of UVA and any other information as may be embedded in the electronic file containing the original STREAMin<sup>3</sup> Curriculum Model.

#### Withdrawal

Unless otherwise expressly agreed to in writing by UVA, UVA does not make, and hereby disclaims, any and all warranties, express or implied, in fact or in law, including, but not limited to, any implied warranties of merchantability, quality, accuracy, or fitness for a particular purpose.

UVA makes no warranty that the STREAMin<sup>3</sup> Curriculum Model will meet your curriculum requirements, student needs, or operate under your specific conditions of use. UVA makes no warranty that use of the STREAMin<sup>3</sup> Curriculum Model will be secure, error free, or free from interruption.

UVA makes no express or implied warranties that your use of the STREAMin<sup>3</sup> Curriculum Model will not infringe any third-party patent, copyright, trademark, or other third-party intellectual property rights.
